Founded in 2008, Misr Technology Services (MTS) plays a critical role in Egypt's digital transformation journey. The company developed and operated the Nafeza platform, the country's single-window customs automation and Advance Cargo Information (ACI) system.

MTS serves as the technical arm of the Ministry of Finance in the fields of customs and its relationship with taxation. It is entrusted with safeguarding national trade data while enabling efficient, secure, and transparent cargo clearance.

With over 1,100 employees and a rapidly evolving digital ecosystem, MTS stands at the forefront of securing critical national infrastructure – where cybersecurity is a matter of national security. Ensuring robust defenses across its platforms and supporting digital infrastructure has become a business-critical imperative.

Business Challenges

As operators of Egypt's national trade platform, MTS faced the dual challenge of:

- Securing complex IT environments spanning applications, infrastructure, networks, and user endpoints before launching.
- Mitigating national security risks, given that any breach could disrupt trade, damage trust, and impact the economy.
- Meeting global compliance standards such as ISO 27001 to strengthen stakeholder confidence.

At the time of engagement in 2018, MTS had already established key security controls across its environment. To keep pace with evolving threats and align with international best practices, they sought a comprehensive review and enhancement of their security posture.
